Main reasons for need of new act of law

1. Unsufficient:

- ✓ application of existing VET law ,
- ✓ motivation of employers for the entrance into VET,
- ✓ awareness of employers about bonuses of recent new act ,
- ✓ reaction of VET for current needs of labour market,

2. Reduction in the percentage of students performing practical training directly by employers,

3. Positive contribution of the dual system in selected European countries.



Working group for developement of the draft Law on VET:

1. Representatives of :

- ✓ the Ministries(MŠVVaS SR, MH SR),
- ✓ employers and employers' associations (SOPK, RUZ, Klub 500, SNOBK),
- ✓ school founders (selfgovernment regions Žilina and Bratislava),
- ✓ employees (OZPŠaV),

2. Working group of national project RSOV(development of VET)



The subject of the new law on VET

- ✓ VET of pupils of secondary vocational schools,
- ✓ kinds of secondary vocational schools and an attribute characterizing the fields of education in which the school provides education and training,
- ✓ process of practical training
 - ✓ the forms of practical training,
 - ✓ the methods of performance of practical training,
 - ✓ the place of performance of practical training (workroom, workplace of employer, workplace of practical training).



The subject of the new Law on VET

- ✓ system of dual education
 - ✓ eligibility of the employer to provide practical training in the dual education (application, verification of eligibility, re-verification of eligibility, termination of eligibility),
- ✓ regulation of mutual rights and obligations of the pupil, secondary vocational school and employer in the dual education
 - ✓ contract of dual education,
 - ✓ contract of apprenticeship,
 - ✓ model learning plans, model curricula, which are part of state curricula



The subject of the new Law on VET

- ✓ employer in the process of practical training, instructor
- ✓ secondary vocational school in the process of practical training, center of VET
- ✓ pupil in the process of practical training
 - ✓ material support of pupil (OOPP, assessment of health, sensory and psychological fitness, travel, accommodation and meal allowance)
 - ✓ financial support of pupil (reward for productive work, motivational scholarship, corporate scholarship, working scholarship)



The subject of the new Law on VET

- ✓ Coordination of VET for the labour market
 - ✓ state level,
 - ✓ level of selfgovernment region.
- ✓ The Ministry of Education, Science, Research and Sport of the Slovak Republic, (fields of education system, norms, model learning plans, lists)
- ✓ The Ministry of Work, Social Affairs and Family of the Slovak Republic, (tracing of pupils or transmittion),
- ✓ The other ministries (sectoral approaches),



The subject of the new Law on VET

- ✓ Selfgovernment region (regional strategy, VZN),
- ✓ Professional organizations,
- ✓ Representatives of employers,
- ✓ Advisory Bodies (government council for VET, county council for VET)
- ✓ Amendment of : Labour Code (contract about future working contract)
- ✓ Law about Chambers, the Income Tax Law
- ✓ Amendments of the School Act, Act about financing of primary schools, secondary schools, special centers and Act about public administration at education and the school selfgovernment
