1. 2. The origin of the strategy

The Ministry of Education, Science, Research and Sport of the Slovak Republic (hereinafter referred to as the "Ministry") has developed the Higher Education Internationalization Strategy 2030 (hereinafter referred to as the "Strategy") on the basis of measure no. 76 of the Implementation Plan of the *National Program for the Development of Education*. The aim of this measure was to create a strategy containing measures to "ensure greater academic mobility of students and university staff, reduce barriers to studying in the Slovak Republic (language of study programs, opportunities to obtain visas and residence permits, scholarship programs), change conditions for enrolling university teachers / researchers, reassessment of the role of tuition fees in study programs conducted in a foreign language, support for integration activities and support for marketing activities aimed at applicants from abroad."

The vision of the National Program for the Development of Education is higher education which is:

- adequately funded, efficiently functioning and systemically supporting the mission of higher education institutions,
- employing high-quality, socially respected and adequately remunerated university teachers and researchers,
- providing education that meets international standards and forms part of the European Higher Education Area (EHEA),
- accessible to all citizens who show interest in it and demonstrate the prerequisites for its successful completion,
- forming the core of Slovakia's research potential in the field of basic research and applied research and being a part of the European Research Area (ERA),
- responding to the current and expected needs of social and economic practice and representing the engine behind development of society and regions of Slovakia.

The Program Statement of the Government of the Slovak Republic for the period 2021 - 2024 declares the following intentions:

- to support high-quality, competitive and efficient higher education in the European context,
- to create mechanisms for higher education institutions that will enable them to obtain funds from external sources,
- to introduce modern forms of teaching,
- to support the opening of the higher education system to the external environment and internationalization.

The Recovery and Resilience Plan of the Slovak Republic sets out reforms and investments in the field of higher education to support internationalization which will be implemented by 2026 and which will be supported by the Mechanism to Support Recovery and Resilience.²

Internationalization of universities is a cross-cutting tool which can significantly contribute to the fulfilment of the set visions in all specified aspects. Modernization of education is closely related to the global development in individual scientific fields, as well as with the management system of higher education. Furthermore, the process of modernization is closely related to the use of the state-of-the-art technologies in education and teaching. It should be noted that internationalization can contribute to the early identification of current trends needed to be implemented in the educational process in order for Slovak universities to withstand global competition.

1. 3. Aim of the strategy

The strategy outlines a medium-term concept targeting internationalization of higher education as an effective tool for improving the quality of education and the research environment at universities in the Slovak Republic by 2030.

The National Program for the Development of Education aims at increasing the quality of higher education through internationalization, increasing the availability of international experience during university studies and modernizing higher education in the context of internationalization.

1.4. Beneficiaries

The beneficiaries of the strategy are universities, national agencies and non-profit organizations operating in the field of internationalization of higher education, science and research and relevant state administration bodies.

1. 5. Basic terms used

The term "internationalization" refers to "the process of integrating the international, intercultural and global dimensions into the purpose, functioning and outcomes of higher education institutions."³ Internationalization cannot be seen as a goal but rather as a tool contributing to meeting goals and improving desired results.

"By "internationalization at home" we mean "the purposeful integration of international and intercultural dimensions into formal and informal curricula for all students within domestic learning environment."⁴

The term "short-term international mobility" refers to mobility lasting less than two months.⁵

The term "long-term international mobility" refers to mobility lasting more than two months or more.

1. 6. Other relevant strategic documents

In 2017, the Communication from the commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee and the Committee of the Regions - Strengthening European Identity through Education and Culture ⁶ announced the start of building a European learning area in which learning mobility will be a reality for all by 2025. The aim is to support language training and innovation in the digital age and build world-class European universities able to work together seamlessly across borders.

*The Skills Strategy Slovak Republic*⁷ sees the skills imbalance reduction and a shift from a "brain drain" to a "brain gain" to be its priority.

*Modern and Successful Slovakia*⁸ outlines the support schemes to attract foreign talent, including university students, researchers and university teachers in order to support the internationalization of universities and knowledge transfer.

*The Digital Education Action Plan*⁹ for 2021 – 2027 in the field of university cooperation aims to create a Europe-wide platform for digital higher education.

The Digital Transformation Action Plan Slovakia for 2019 - 2022, following on from the 2030 Digital Transformation Strategy of Slovakia in the field of modernization and opening of the labour market sets out to support the enrolment of the best applicants for university studies and highly qualified experts in research institutions from abroad.

The aim of the 2030 Agenda for Sustainable Development¹⁰ is to ensure that all learners acquire the knowledge and skills needed to promote sustainable development primarily but not exclusively through the concept of global citizenship and appreciation of cultural diversity.

Communication from the commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee and the Committee of the Regions - A New Era for Research and Innovation¹¹ sets investment and reform priorities, improved access to excellence, using research and innovation results in practice and deepening policies promoting free circulation of knowledge as strategic objectives for the new European Research Area.

Communication from the commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee and the Committee of the Regions - Achieving the European Education Area by 2025¹² to be built in synergy with the European Skills Agenda for Sustainable Competitiveness, Social Fairness and Resilience, the Digital Learning Action Plan and the European Research Area.

Council Recommendation on promoting automatic mutual recognition of higher education and upper secondary education diplomas and the outcomes of learning periods abroad¹³ calls on EU Member States to recognize the outcomes of study stays abroad as well as education diplomas by 2025 in order to have access to further studies.

The Recovery and Resilience Plan of the Slovak Republic sets out reforms and investments in the field of higher education to support internationalization to be implemented by 2026. These are to be supported by the Mechanism to Support Recovery and Resilience.

2. Definition and analysis of the problem

2. 1. Definition of the problem

As part of the European Higher Education Area and the European Research Area, Slovak higher education adheres to the principles of cooperation, coordination and streamlining of joint activities. In order to achieve the common goals of these initiatives, the Slovak higher education must meet international standards in education and research.

In the context of the globalization of societies, economies and labour markets, universities are facing increasing demands on the education system and on science and research outputs. The development of the global knowledge economy places new demands on universities in the area of preparing future graduates for the profession on an international scale. At the same time, in the conditions of negative demographic development, the challenge for Slovakia is to provide a skilled workforce to increase competitiveness and sustainable economic growth. Aging population and decline in the working-age population¹⁴ is in sharp contrast to the building and sustainable development of the economy, with the prospect of a high proportion of the highly qualified working-age population. At the same time, Slovakia is in a highly competitive environment for the development of modern technologies and the development of the so-called smart solutions and the ability to attract investment and foreign resources for research, development and innovation are currently lagging behind, with the exception of a few workplaces. With regard to these changes and demands, it is necessary to develop modern and high-quality higher education attractive for Slovaki and foreign students and university employees with potential to contribute to the innovation potential of Slovakia.

With regard to the growing global movement of people, Slovak universities are forced to compete for domestic and foreign students interested in studying at universities. Slovakia's position as a destination for study is currently weak¹⁵. The country has long faced the problem of a growing proportion of students enrolling at universities abroad (especially in the Czech Republic), while research shows that high school graduates with the best results in the external part of the school-leaving examination go abroad¹⁶. The increasing number of foreigners who come to study at Slovak universities for the entire length of their studies cannot compensate for the overall decline in students interested in studying at Slovak universities also caused by the outflow of Slovak students abroad¹⁷. In 2018, 31,472 students with Slovak citizenship studied at universities abroad¹⁸, while only 12,706 foreigners enrolled in study programs at universities in the Slovak Republic in the academic year 2018/2019¹⁹.

Slovak universities have problems attracting foreign university teachers and researchers to work longer-term²⁰ i.e. longer than stays carried out within the framework of international mobility. This problem is caused mainly by various administrative and legal obstacles. One of the obstacles is the limitation imposed on the position of "associate professor" and "professor" – the positions may not be filled in by a person without a scientific-pedagogical title or an artistic-pedagogical title of "associate professor" or "professor" for a period longer than three years. Various aspects related to the exercise of the rights and obligations of foreigners in relation to longer stays in Slovakia, including the administrative complexity of some processes, may also negatively affect the interest of foreigners to work and study at Slovak schools.

In terms of increasing the attractiveness of studies, the readiness and potential of universities to attract foreigners has improved over the last two decades due to the creation of separate subjects taught in English (especially under the influence of mobility programs such as Erasmus +), thus expanding the range of study programs taught in foreign languages²¹, deepening cooperation with foreign universities thanks to joint study programs ²², which, with the growing number of foreign students coming to Slovakia²³ indicates an improvement in the readiness of Slovak university teachers to lecture and teach in a foreign language.

In terms of developing skills needed in the globalized world, internationalization promotion is an important aspect of making the opportunity to gain international experience widely available, as it is international experience which contributes to the development of language skills, intercultural competences and expertise. In the case of university students, the primary form of gaining international experience is international mobility, either for the purpose of study or internship (usually on the basis of a scholarship or grant program)²⁴. The ET 2020 Strategic Framework for European *Cooperation in Education and Training*²⁵ set the target value for the International Mobility Indicator, according to which by 2020 at least 20% of EU university graduates should have completed international mobility for study or training purposes (including internship) abroad - either at least 15 ECTS credits or for a duration of at least three months. With regard to these target values, Slovakia manages to send only a low proportion of students to international mobilities, while only 5.24% of graduates graduating in the academic year 2019/2020 completed mobility lasting at least two months during their studies²⁶. The recent statistics on participation in mobilities show a growing interest in internships abroad. This might be also caused by a change in the expectations of future graduates, for whom internships are an attractive means of acquiring practical skills for future employment. On the contrary, interest in study stays stagnates/ grows only slightly, especially in the first and second level of study.

Information and counselling on mobility opportunities, knowledge of foreign languages, portability of scholarships and loans, support for disadvantaged students and recognition of learning outcomes are considered to be key factors²⁷ influencing students' motivation and opportunities for international study or internships. According to the latest surveys, ²⁸ students of Slovak universities most often perceive the need to meet missed study obligations after returning from abroad to be the biggest obstacle to completing international mobility²⁹. Other obstacles include administrative complexity of international mobility, insufficient amount of funds to cover costs abroad, lack of information about mobility opportunities on the part of the home university, insufficient knowledge of a foreign language and unattractive offer of partner universities abroad.

In order to introduce an international context to each student, regardless of their ability to take part in student mobility or internship abroad, it is necessary to focus on tools allowing international experience in the domestic academic environment (so-called internationalization at home). Slovak universities integrate the international and multicultural dimension into the content of their studies by offering study programmes and classes in foreign languages, and, to a lesser extent, by organizing international summer schools. Compared to the situation abroad, the Slovak Republic still pays little attention to the digitization³⁰ of education and development of virtual or mixed mobility where students participate in courses and classes offered by a foreign university electronically and also gain (to a limited extent) benefits of classic physical mobility without the need to travel abroad. The COVID-19 pandemic has accelerated the onset and development of online forms of education and has further highlighted the need to stimulate internationalization in this area as well.

An important principle of international mobility is the effort to balance the numbers of sent and hosted students and university staff. At present, Slovak universities send a significantly higher number of students to mobility than they host (in the academic year 2019/2020, they sent 2,172 students for mobility and hosted 1,517 students³¹). The lower interest in completing mobility at Slovak universities may also be related to the offer of scholarships in some scholarship programs financed from the state budget, the amount ³² of which does not cover the real cost of living in Slovakia.

The exchange of knowledge on a global scale must be a priority if Slovak universities are to provide education for the globalized labour market and achieve more significant results in the international field. Nevertheless, the system is still very rigid. According to the latest surveys,³³ Slovak university teachers are primarily focused on cooperation with other Slovak universities and not with foreign partners, while the trend at internationalized universities is just the opposite. The share of foreign university teachers and researchers³⁴ is not increasing fast enough and domestic university staff often report their inability of to undergo mobility (due to management's reluctance to create conditions for longer mobility stays abroad, problems with leaving the workplace due to scheduling conflicts,

administrative complexity, etc.)³⁵. Even though some positive impulses have been recorded (as evident from the development trends), the rigidity of the system prevents fundamental changes.

In addition to the benefits for the universities themselves, internationalization also brings benefits for the society as a whole. With the development of the knowledge economy, the importance of scientific diplomacy and cooperation in education and research in bilateral and multilateral partnerships is growing, too. The way a country presents itself through education, exchange of knowledge and cultural identity is an important aspect of cultural diplomacy. Therefore, Slovakia should strive to build an image of a trustworthy, safe and responsible partner. At the same time, higher education also plays an important role in international development cooperation³⁶.

The natural change in the individual needs of students and staff in the context of increasing demands on the higher education system requires a change in the internationalization conditions and planning. Strategic decision-making and planning must be based on a vision and perspective (proactive and forward-looking) and not tackle current shortcomings and needs. Although the current problems require and provide the most impetus for the necessary changes, it is necessary to set goals with future in mind (one to two decades ahead). The process of internationalization is influenced by many factors and actors, ranging from the internal environment of schools to the international situation. These facts must be taken into account and evaluated if the desired internationalization goals are to be achieved. For this reason, too, internationalization efforts need to be supported on an ongoing basis, along with further changes to the system.

2. 2. Review of existing measures

Over the past two decades, several government initiatives have been implemented to improve international cooperation in higher education and science with a view to strengthening the development of the knowledge economy. *The Concept of Further Development of Higher Education in Slovakia for the 21st century* from 2000 recommended strong support for the international mobility of employees and students of Slovak universities and also highlighted the need to create conditions for mutual mobility so that the participation rate in mobility increases from 1% to 3 - 5%. Subsequently, the *Minerva Knowledge Society Government Development Program* was adopted in 2005, under which a *National Scholarship Program* was created to support the mobility of students, doctoral students, university teachers and researchers. This government program was followed in 2011 by *the Minerva 2.0 - Slovakia Top League Strategy*, which indicated a shift towards a systemic and cross-cutting approach to the internationalization of higher education, science and research, emphasizing the removal of administrative barriers to the arrival of foreign highly qualified university staff and students and the coordination of the promotion of Slovak universities abroad.

The gradual transition from the perception of internationalization as a standalone goal to its integration into individual areas of university life as a means of improving the quality of university activities was declared in the *Long-term Intention of the Ministry of Education in Educational, Research, Development and Other Creative Activities for Universities for 2016-2021*. As part of its implementation in the years 2017 to 2019, the Ministry supported projects aimed at improving the quality of higher education through internationalization in the total amount of 2.85 mil. EUR³⁷ at nine public universities. Thanks to the support, existing study programs provided in foreign languages were innovated, new study programs have been introduced and experts from universities abroad were

invited to lecture in order to improve study programs and activities supporting the development of PhD students' skills necessary for their involvement in international projects and international research have been implemented.

With the aim to open universities to professionals from abroad, the qualification requirements for the employment of university teachers (the positions of associate professor and professor) were adjusted in 2018. As part of this regulation, it was possible to fill in the positions of associate professor and professor with a person without a scientific-pedagogical title or an artistic-pedagogical title of "associate professor" or "professor" for a maximum of three years.

In 2019, the Ministry supported nine public universities with the amount of 251,832 EUR to prepare grant applications for the project Alliance of European Universities in the second round of the Erasmus + call: Key Action 2 - Innovation Cooperation and Exchange of Best Practices - European Universities. Three Slovak universities (Comenius University in Bratislava in the ENLIGHT alliance, the Slovak University of Agriculture in Nitra in the INVEST alliance and the Technical University in Košice in the ULYSSEUS alliance) succeeded under the call. Over the three-years duration of the project, each alliance of European universities will create a common learning space in which students and staff can move (physically and virtually) smoothly and freely to study, train, teach, do research, work or provide services at any partner university.

3. Vision and strategic direction

3. 1. Intervention logic, hierarchy of strategy goals

The intervention framework is based on the results achieved in the field of internationalization so far on the basis of internationalization tools developed at Slovak universities over the past two decades. In this initial phase of internationalization development, the implementation stage of the strategy made use of activities initiated mainly on the basis of the individual interests of universities, initiatives at national level and funding opportunities at EU level. In order to achieve the purpose of internationalization as a tool for improving the quality of higher education and the research environment in higher education, it is necessary at this stage to move from relatively isolated activities to their implementation on the basis of a systemic internationalization framework (defined at national level) so that the concept of internationalization becomes an integral part of the policy of Slovak universities.

This strategy aims at increasing the efficiency of activities and invested resources in the field of internationalization and maximizing their benefits for Slovak higher education and wider society by introducing a systematic and coordinated approach to internationalization based on common goals of the Ministry and universities. With regard to the above, the introduction of indicators related to internationalization into the measurable indicators will be considered. These indicators are part of the contracts for the provision of subsidies to public universities. Therefore, funds provided to universities are provided based on these indicators.

The set measures will ensure the institutional background at the level of universities and support the quality of institutional strategic planning in the field of internationalization through funding of existing activities, introduction of new funding schemes and improving the implementation of internationalization efforts regulatory framework.

3. 2. Vision and global goal

In order to improve the quality of higher education and research as well as the competitiveness of Slovak universities in the European Higher Education Area and on a global scale, the goal of the Slovak Republic is to have higher education which in 2030 will:

- offer quality study programs with an international reputation,
- offer opportunities for establishing and developing quality partnerships in the field of education and research with universities from abroad,
- provide future university graduates with knowledge, skills and competences useful in a globalized labour market,
- stimulate universities to implement best international practice in all spheres of social life, both at the national and local level.

This global goal has been further developed into three key strategic goals which will be achieved by supporting and developing cross-cutting and auxiliary aspects related to the arrival and stay of foreign students and university staff in the Slovak Republic.

3. 3. Strategic goals

- 1. Improving the quality of higher education through internationalization
- 2. Increasing the availability of international experience during studies
- 3. Modernization of higher education in the context of internationalization

4. Description of goals in individual strategic areas

4. 1. Name and description of a specific goal, impacts of its fulfilment

Strategic goal 1. Improving the quality of higher education in Slovakia through internationalization

Goal 1.1 Development of quality study programs provided in foreign languages

In order to increase the attractiveness of studies in Slovakia for potential students from Slovakia and abroad alike, universities will work on the offer of study programs provided in foreign languages, including new joint study programs developed in cooperation with universities from abroad. To ensure the high quality of study programs, internal documents of higher education institutions will contain clearly identifiable aspects for the regular assessment of the degree of internationalization at the level of study programs and at the level of higher education institutions.

Goal 1.2 The international dimension of study programs enabling international experience at home

Universities will integrate the international dimension into the study programs and the university environment. This will enable every student to gain international experience in their domestic academic environment. Internationalization not only of the content of study programs, but also of the teaching process itself will ensure interaction between Slovak and foreign students in joint study programs and ensure new teaching approaches thanks to visiting foreign university teachers. Further benefits include development of knowledge, improved language skills and intercultural competencies³⁸ of future Slovak university graduates on the international and domestic labour market.

Goal 1.3 Quality working environment for university teachers and researchers

With the intention of creating a quality working environment for core university teachers and researchers, universities will implement international standards in human resource management strategies, introduce ethical rules in research and create an environment enabling networking of professional workplaces, e.g. implementing the principles of the European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers³⁹, which are part of the HRS4R Human Resources Strategy for Researchers⁴⁰, into the internal quality assurance system of higher education institutions. University staff will be supported in their endeavours to develop international cooperation and make contacts at universities abroad right from the beginning of their research career through traditional mobilities, real opportunities for longer-term stays in the form of so-called sabbaticals for university teachers (a creative break from work - the university teacher is released from teaching duties for a predetermined period of not less than 6 months while their employment continues without a change. Person on a sabbatical should focus exclusively on skills development, professional growth, research in their field. This period can be spent abroad at a foreign university or research institution such stays create new and strengthen already existing ties and bonds between institutions from abroad and domestic university and support professional growth of the employee, thus increasing the quality of the domestic institution upon return).

In order to create conditions for professional growth of university teachers and researchers, as well as to increase the quality of their outputs, the Slovak Republic will create stimulating conditions for the involvement of universities in research⁴¹ at an international level including support for creating synergies with European Union programs, especially the EU Framework Program for Research and Development Horizon Europe (including mobility supported by the Marie Sklodowska-Curie / MSCA Actions) and the EU Education and Training, Youth and Sport Erasmus + program. The possibility of complementarity between existing programs and schemes financed from the state budget and these EU programs will also be considered.

Goal 1.4 Opening of job positions for university teachers and researchers working abroad

With a view to maintaining and enhancing the quality of higher education and ensuring the competitiveness of institutions on a global scale, higher education institutions will develop supportive tools to **increase international job openness for higher education teachers and researchers**, in particular to stimulate long-term employment and retention of high-quality staff in order to compete with employees from abroad and lure back Slovak researchers working abroad. **Posting job vacancies on international researcher portals**, such as EURAXESS Jobs or Nature, will help attract high-quality staff.

Strategic goal no. 2. Increase the availability of international experience during studies

Goal 2.1 Make information about study opportunities at universities in Slovakia widely available to foreign students

Information on study opportunities at universities in Slovakia will be provided in a **transparent and user-friendly way** through the Portál vysokých škôl Universities Portal, a new website promoting study opportunities in the Slovak Republic (the "Study in Slovakia")⁴² and websites of individual universities⁴³. As with study programs provided in foreign languages, the offer of study programs provided in Slovak will also be available in foreign languages, **at least in English**, so that those who are considering studying a study program in Slovak will be able to study the program even though they not yet have full command of the language (and are taking a language course). At the level of higher education institutions, the specific conditions for admission and the requirements for proving their fulfilment will be published on Europass.

Goal 2.2 Active promotion of study opportunities at Slovak universities among potential applicants for study abroad

In the interest of effective presentation of study opportunities in Slovakia, **nationally coordinated activities (also those developed by universities) aimed at promoting Slovakia will be implemented**. The establishment of a joint **concept "Study & Research in Slovakia"** under the concept Good Idea Slovakia and more intensive use of various means of promotion (e.g. social media, physical and virtual fairs) will increase the visibility of Slovak higher education and research. **Slovak embassies abroad will be involved in the promotion of study opportunities in Slovakia**. The embassies will be provided with methodological and material support and information on planned activities in their territories (including joint activities covered by the European Commission) through a central organization in charge of promoting Slovak higher education abroad.

Goal 2.3 Modernization of the admission procedure and active recruitment of potential foreign students

From the point of view of potential students from abroad, the quality of counselling in the admission process, the active interest on the part of universities and the timeliness of the admission results are the biggest motivating factors. Applicants from abroad will have access to counselling at universities regarding documentation needed. In order to reduce the administrative complexity of the process of proving the fulfilment of the basic conditions for admission to studies universities will, in the case of students from abroad, issue a decision on the fulfilment of education-related conditions for the purpose of university enrolment. With regard to the admission process, universities **will move to the recruitment of talents**, i.e. active recruitment⁴⁴. In order to do that, the admission procedure will have to be adapted to reflect the move while the effort will also have to be made to maintain students' interest in studying at the university of choice, for example by using the admission procedure model under which applications are assessed and notified either continuously until the program capacity is filled or within the set deadlines. If possible, universities will cooperate with embassies of the Slovak

Republic abroad/reliable organizations chosen for presiding over university admission test outside Slovakia.

In promoting the possibilities of study, the ethnic diversity of the student population will be taken into account in order to increase the effects of cultural exchange. By focusing on various territorial areas when promoting study opportunities, the quality planning and sustainability of talent recruitment in terms of geopolitical and demographic development in the world. The balanced geographical background of foreign students will limit the emergence of large monocultural groups of students in study programs and will have a positive impact on their motivation to integrate in Slovakia.

In order to stimulate the interest of students from abroad in studying at Slovak universities, the Ministry will introduce a national scholarship scheme **to provide full scholarships**⁴⁵. Through scholarships and by setting up ongoing checks on the results achieved by students, it will be possible to support the integration of foreign students. The aim is to support students from abroad in learning Slovak during their studies to help them integrate.

Goal 2.4 Integration of students from abroad in the academic environment and university social life

In accordance with the principles of an open, tolerant and welcoming society, foreign students studying in Slovakia will be provided with conditions which will help them integrate into social and working life (with a view to their potential employment in the Slovak labour market after graduation).

In order to facilitate the adaptation of foreign students in a new academic and social environment, they will have opportunities to adapt to the new socio-cultural environment at the beginning of their studies and also make use of counselling during their studies. At the same time, in order to promote intercultural understanding, universities will have mechanisms in place to prevent and resolve socio-cultural-based conflicts and issues, including support for school staff in such situations⁴⁶.

In order to ensure a comparable quality of study, social life and provided services, universities will, with regard to the existence of language barriers, develop an open and friendly environment for foreign students by making the university's internal regulations available in a foreign language⁴⁷, introducing multilingual bulletin boards and signs and ensuring foreign students will be able to

communicate in foreign language⁴⁸ not only at the administrative and professional workplaces of the university, but also in catering and accommodation facilities and when handling other daily practical matters.

Universities will provide or ensure Slovak language courses (Slovak as a foreign language) in order to increase not only the integration potential of foreign students but also their employment chances. To support their integration into the labour market, universities will provide foreign students with targeted career counselling, including support in legislative requirements, provided such students wish to work during and after their studies, taking into account their specific position in terms of labour and residence legislation, language skills and other aspects.

Goal 2.5 Support for existing scholarship programs to open up to the international mobility programs for students, university teachers, researchers and artists

The aim is to increase the number of mobilities (especially those coming to Slovakia) and their quality so as to create a better and more positive perception of Slovakia and style it as a great destination for mobility and as a country systematically and purposefully investing in international cooperation.

In order to maintain and increase the participation students and university staff in international mobility, **existing programs**⁴⁹ **will continue to be supported (for international students, university teachers, researchers and artists).** At the same time, opportunities will be sought to enable mobilities to be funded from several sources (e.g. Erasmus +, national scholarship program, other programs) and allow new co-financing instruments for existing scholarship and grant schemes to be introduced (e.g. in relation to Erasmus +). Increasing the funding rate of selected scholarship programs will boost the attractiveness and competitiveness of the programs in terms of scholarships provided in comparison with other countries and the total number of scholarships provided. The support envisages scholarship bonuses for students and staff with special needs.

With a view to improving information on the readiness to host international students and staff with special needs, higher education institutions will indicate in their interinstitutional agreements whether they have the necessary infrastructure to receive people with special needs. At the same time, universities will register information on the accessibility of their academic environment and the services provided to students with special needs in international online databases⁵⁰ created to promote inclusive mobility.

Goal 2.6 To promote the automatic recognition of learning outcomes achieved during mobility period

In order to enable international mobility for as many students already studying at Slovak universities⁵¹ as possible, it is necessary to minimize the obstacles associated with scheduling, study obligations arising out of the study plans and the recognition of study outcomes achieved during mobility period. Universities will create so-called mobility **window**⁵² in their study plans. The mobility window **provides students with a period of time reserved for international student mobility embedded into the curriculum of a study programme.**⁵³ Scheduling study obligations (these can be fulfilled at a partner university abroad on the basis of a pre-agreed study contract and later confirmed in the study results report) for a specific year of study in the study plan will significantly contribute to achieving automatic recognition of learning outcomes achieved during international mobility by the sending university. The period of time created by the introduction of the mobility window can also be used for other forms of **internationalization at home** for students who do not take part in international mobility but wish to have an opportunity to gain international experience at home.

Strategic goal 3. Modernization of higher education in the context of internationalization

Goal 3.1 Using the possibilities of evaluating the quality of internationalization processes

Internationalization is a dynamically evolving and changing concept and its implementation and timely addressing can bring in a competitive advantage compared to foreign universities. The Ministry will support the activities of universities **aimed at evaluating the quality of their internationalization processes** and subsequently provide support in developing aspects of internationalization according to the results and recommendations of the evaluation and their own objectively identified needs.⁵⁴

Goal 3.2 Support for networking at the universities level and modernization of administration processes

The Ministry will support the development of partnerships and networking of universities with universities abroad through grant and mobility support⁵⁵ and by supporting the involvement of public universities in the European Universities initiative. In order to develop cooperation in the field of

research and development, universities will be able to use national grant resources for the activities of foreign partners in joint projects⁵⁶.

In order to promote Slovak higher education, the Ministry will support the participation of representatives of Slovakia and Slovak universities in key international events in the field of internationalization of higher education (especially conferences and fairs organized by the European Association for International Education (EAIE), Asia-Pacific Association for International Education (APAIE), the Association of International Educators (NAFSA), etc.). Participation in these events will promote Slovakia as a country suitable for studying and establishing cooperation in the field of higher education on a global scale. Representatives of Slovak universities will have a unique opportunity to establish new and strengthen already existing partnerships. At the same time, the Ministry will support specific universities in their participation in specific fairs with a view of recruiting students from predefined territories. The acquisition and exchange of knowledge and learning about the latest trends in internationalization will have an immense effect on the functioning of the university and the professionalization and development of human resources.

Goal 3.3 The use of digitization and information and communication technologies in the internationalization of teaching

With regard to the development brough on by the onset of COVID-19 pandemic, recommendations for and best practices in the use of online technology and innovation in higher education were brought to the forefront. The intention is to support universities in providing online courses in cooperation with partner universities abroad. The introduction of systems to support the so-called virtual mobility along with Collaborative Online International Learning (COIL) is expected. Monitoring international trends in online cooperation and introducing an international dimension to the educational process is essential for the modernization of education and increasing its quality at Slovak universities.

Cross-cutting objective: Developing cross-cutting and supporting aspects influencing internationalization

The internationalization of Slovak universities, as well as the need to increase the attractiveness of the Slovak Republic to attract foreign students and university teachers and researchers depends **not only on the readiness and development of universities, but also on the overall internationalization framework and other rules outside the Ministry itself**. It is necessary to create such conditions for foreign students, researchers and university teachers, which will encourage them to come to Slovakia and choose it from the myriad of other options on the global level (i.e. other countries already significantly more internationalized in higher education and research).

The Ministry will address the complex issue of administrative and other obligations closely related to the arrival and stay of foreigners, especially from third countries, the change of which would rapidly speed up administrative processes and remove numerous barriers (including specific evaluation in relation to the implementation of the Erasmus + grant program). At the same time, it is assumed that existing and newly adopted measures to support internationalization will be evaluated on an ongoing

5. Strategy implementation

5. 1. Implementation structure and management system for strategy implementation

The Ministry, as the manager of the strategy implementation, will set up a steering committee to implement the strategy. The members of the committee shall include the Minister/ the Secretary of State, relevant managing heads of the relevant departments.⁷⁴

The steering committee:

- oversees the implementation of the measures resulting from the strategy
- ensures the coordination of cooperation with the responsible entities
- sets up working groups for the implementation of measures
- approves changes to the strategy and changes to the strategy budget
- approves the proposal for the mid-term and final evaluation of the strategy implementation

In the case of requests or proposals for changes in the strategy implementation, the responsible department shall record these proposals, analyze their expected impact on the time frame of implementation, budget, implementation of measures and achievement of set objectives and submit the opinion to the steering committee. The steering committee shall decide on the approval or rejection of the submitted request or proposal for amendment. If approved, the responsible department shall incorporate the approved changes into the implementation strategy or plan.

To coordinate a cross-cutting approach to issues related to the arrival and stay of foreign students and university staff in Slovakia, an inter-ministerial working group will be established consisting of representatives of MESRS SR, MFAEA SR, MI SR, MLSAF SR, MH SR and representatives of Slovak Conference of Rectors, the Council of Higher Education Institutions, the Student Council of Higher Education Institutions, the Slovak Accreditation Agency for Higher Education, SAIA, n. o., the Slovak Academic Association for International Cooperation and representatives of organizations operating in the field of migration (e.g. the International Organization for Migration).

5. 3. Budget and funding

The budget for the implementation of the strategy is compiled for the period 2021 - 2026. Following the review of the measures, implementation process and possible preparation of action plans, the budget will be revised and later updated for the period 2026 - 2030. Where possible, EU funds will also be used to finance the implementation. A detailed budget is given in Annex 3.

5. 4. Strategy implementation monitoring and evaluation system

The Ministry's organizational unit designated by the steering committee will be responsible for monitoring the implementation of individual measures and updating the objectives and measures of the strategy. The success of the implementation of the strategy, including the fulfilment of the set scope of measures, time frame and budget, will be regularly evaluated at biennial intervals through the measurable indicators set for individual objectives and measures and presented in the monitoring report on the implementation of the strategy. Based on the results, it will be possible to revise and update the strategy through action plans planned for the selected period.

5. 5. Risk management system and strategy implementation assumptions

In 2020, activities in the field of internationalization of universities requiring cross-border movement were significantly affected by the adoption of measures in connection with the spread of COVID-19.

With regard to the implementation of the strategy in the context of the spread of COVID-19, the main interest of the Ministry will be to protect the health of students and university staff. The measures of the strategy will be implemented in accordance with the epidemic situation and guidelines and recommendations of the state administration bodies.

Assumptions regarding strategy implementation:

- Political sustainability of the set objectives and measures throughout the strategy implementation period
- Stability of the set financial framework for the implementation of the strategy
- Cross-cutting approach in cooperation with the relevant ministries to create favourable conditions for achieving the set goals
- Absence of significant restrictions on cross-border movement due to exceptional circumstances

An organizational unit of the ministry will be responsible for monitoring the risks during the process of strategy implementation. In the risk event, an alternative measure will be taken, if possible.

6. Strategy creation process

6. 1. Strategy authors and stakeholders

The authors of the strategy are employees of universities. Representatives of universities, nongovernmental organizations operating in the field of internationalization (especially SAIA, n. o. and other participating and cooperating entities) are involved in the creation of the strategy (e.g with regard to the preparation of the component 10 of the Recovery and Resilience Plan of the Slovak Republic, employees of the Value for Money Department of the Ministry of Finance of the Slovak Republic).

6. 2. Description of the strategy creation process

The strategy was prepared in the period from November 2019 to September 2021. In March 2020, a meeting of the Higher Education department with representatives of higher education institutions and NGOs working in the field of internationalization of higher education was held. The stakeholders presented their ideas and discussed the relevance of the proposed strategy objectives and measures. In January 2021, the draft strategy was submitted to the representatives of the European Commission under the measure "4.3 Strategic policy framework for education and training at all levels" in accordance with the EU Cohesion policy in 2021-2027. During February and March 2021, negotiations regarding the Recovery and Resilience Plan of the Slovak Republic took place. The negotiations also tackled some measures of the strategy. In April 2021, the draft strategy was presented to members of the Monitoring Committee for the Operational Programme Human Resources Development.




