

**Announcement of the Election of the Candidate for the Position of Rector of Comenius
University Bratislava
for the Term of Office from 1 February 2027 to 31 January 2031**

The Academic Senate of Comenius University Bratislava, pursuant to Section 10(5) of Act No. 131/2002 Coll. on Higher Education Institutions and on Amendments and Supplements to Certain Acts, as amended, Article 22(3)(c) of the Statute of Comenius University Bratislava, and Internal Regulation No. 11/2024 Rules for the Election of the Candidate for the Position of Rector of Comenius University Bratislava and for the Adoption of a Proposal for the Dismissal of the Rector of Comenius University Bratislava, as amended by Amendment No. 1 (hereinafter referred to as the “Rules for the Election of the Rector Candidate”), hereby announces the election of the candidate for the position of Rector of Comenius University Bratislava (hereinafter referred to as the “Rector of CU”) for the term of office from **1 February 2027 to 31 January 2031**.

The election of the candidate for the position of Rector of CU will take place at a meeting of the
Electoral Assembly
on **4 November 2026 at 14:00** in the Aula of Comenius University Bratislava,
Šafárikovo námestie 6, Bratislava.

The period for submitting nominations for candidates for the position of Rector of CU is **from 1 April 2026 to 30 June 2026 until 12:00 noon**.

The right to submit nominations for candidates for the position of Rector of CU is vested in members of the academic community of Comenius University Bratislava and members of the Board of Trustees of Comenius University Bratislava.

A nomination for a candidate for the position of Rector of CU must be submitted in written form and must contain the particulars stipulated in Article 5(3) of the Rules for the Election of the Rector Candidate. A recommended template for submitting a nomination for a candidate for the position of Rector of CU forms an annex to this announcement.

Nominations shall be addressed to the Chair of the Election Committee for the Election of the Candidate for the Position of Rector of CU and submitted via the Registry Office of the Rectorate of Comenius University Bratislava in a sealed envelope marked **“Election of the Candidate for the Position of Rector of CU.”**

The public hearing of candidates for the position of Rector of CU will take place at a meeting of
the Electoral Assembly
on **26 October 2026 at 14:00** in the Aula of Comenius University Bratislava,
Šafárikovo námestie 6, Bratislava.

The accompanying documents shall be addressed to the Chair of the Election Commission for the Election of the Candidate for Rector of Comenius University and, in copy, to the Deputy Chair of the Election Commission for the Election of the Candidate for Rector of Comenius University, and shall be submitted by electronic mail. The Chair of the Election Commission for the Election of the Candidate for Rector of Comenius University shall confirm the receipt of the accompanying documents by return e-mail.

Information on Personal Data Protection

Your personal data will be made available to the members of the Election Commission, the employee of the Office of the Academic Senate of CU, and the members of the Academic Senate of CU, and, to the extent specified above in this nomination, will be published on the CU website and on the official CU notice board.

We process your personal data **for the purpose of fulfilling our legal obligations** pursuant to Article 6(1)(c) of the GDPR* and for the performance of tasks carried out in the public interest pursuant to Article 6(1)(e) of the GDPR. Without providing your personal data, you cannot nominate a candidate for Rector, nor can you stand as a candidate for the position of Rector.

Pursuant to Article 21 of the GDPR, you have the right to object at any time to the public interest pursued by us.

We also process your personal data for the purpose of performing tasks in the public interest. You have the right to object to this public interest at any time.

If you object, CU may no longer continue to process your personal data unless it demonstrates compelling legitimate grounds for the processing which override your rights or interests, or grounds for the establishment, exercise, or defence of legal claims.

You may exercise your right to object, as well as your other rights, by submitting a request electronically or in writing to our **Data Protection Officer**, who supervises the processing of personal data at CU. **The contact details are:**
