

## **Announcement of the election of a candidate for the position of Rector of the Academy of Arts in Banska Bystrica**

The Academy of Arts in Banska Bystrica (hereinafter referred to as „the Academy of Arts“) pursuant to Section 10 (5) of the Act No. 131/2002 Coll. on Higher Education and on Amendments and Additions to Certain Acts as amended, Article 10 (3) of the Statute of the Academy of Arts in Banska Bystrica and in accordance with the Principles of the Election of a Candidate for the Rector and the Acceptance of the Proposal for the Rector´s Removal (hereinafter referred to as „the Principles“), hereby

### **the election of a candidate for the position of Rector of the Academy of Arts in Banska Bystrica**

**for the term of office from February 20, 2024 to February 19, 2028**

**The term for submission of proposals** for candidates for the position of Rector of the Academy of Arts is set **from May 18, 2023 to September 12, 2023**.

The proposal of the candidate with the attachments shall be submitted in writing to the Chairman of the Academic Senate of the Academy of Arts, to the address: Academy of Arts in Banska Bystrica (Akadémia umení v Banskej Bystrici), Chairman of the Academic Senate of the Academy of Arts (predseda Akademického senátu Akadémie umení), Kollárova 22, 974 01 Banská Bystrica, in a sealed envelope marked „Proposal of a candidate for the Rector – DO NOT OPEN“. The proposal must be delivered to the registry office no later than September 12, 2023 at 1:00 pm.

The proposal of the candidate for the Rector of the Academy of Arts must include the following:

- a) data about the candidate for the Rector (name, surname, title, date of birth, address of permanent residence/address for delivery of documents, e-mail address/telephone number)
- b) professional resume of the candidate for the Rector,
- c) written consent to candidacy: "With my signature, I hereby confirm that I agree with my candidacy for the position of Rector of the Academy of Arts in Banska Bystrica, for the tenure spanning from February 20, 2024 to February 19, 2028.",
- d) written consent of the candidate to the processing of their personal data,
- e) affidavit of the candidate on the fact that he meets the conditions of incompatibility of functions according to Section 10 (4) of the Act No. 131/2002 Coll. on Higher Education,
- f) an extract from the criminal record of the candidate not older than three months,
- g) written development strategy of the Academy of Arts in Banska Bystrica,
- h) data about the proposer (name, surname, title, address of permanent residence/address for delivery of documents, e-mail address/telephone number)

The members of the academic community of the Academy of Arts and members of the Board of Trustees of the Academy of Arts shall have the right to propose candidates for the election of a candidate for the Rector of the Academy of Arts in accordance with Article 2 (6) of the Principles.

The election assembly, whose members include all members of the Academic Senate and all members of the Board of Trustees of the Academy of Arts in Banska Bystrica, will be held on **October 10, 2023 at 10:00 am**. The election of the candidate for the position of rector will be carried out by secret ballot. The venue for the election is the Theatre Hall of the Faculty of Dramatic Arts of the Academy of Arts, Horná 95, Banska Bystrica.

Proposals that do not meet the specified conditions shall be excluded in accordance with the Principles.
