

**ANNOUNCEMENT OF THE REPEATED ELECTION OF THE
CANDIDATE FOR RECTOR OF
THE CATHOLIC UNIVERSITY IN RUŽOMBEROK
FOR THE FOUR-YEAR TERM OF OFFICE 2026 – 2030**

The Chair of the Academic Senate of the Catholic University in Ružomberok (hereinafter referred to as the "AS CU Chair") pursuant to Section 10(5) of Act No. 131/2002 Coll. on Higher Education Institutions and on Amendments and Supplements to Certain Acts as amended (hereinafter referred to as the "Higher Education Act") and pursuant to Article 2(1) of the internal regulation Principles for the Election of a Candidate for Rector and the Acceptance of a Proposal for the Dismissal of the Rector of the Catholic University in Ružomberok (hereinafter referred to as the "Principles for the Election of a Candidate for Rector"), **announces the repeated election of a candidate for rector of the Catholic University in Ružomberok** (hereinafter referred to as "CU") **for the four-year term of office 2026 - 2030.**

Pursuant to Section 10(3) of the Higher Education Act and Article 3(1) of the Principles for the Election of the Rector, the rector shall be elected by an electoral assembly consisting of all members of the Academic Senate of the Catholic University in Ružomberok (hereinafter referred to as "AS CU") and all members of the Board of Trustees of the Catholic University in Ružomberok (hereinafter referred to as "BT CU"). The electoral assembly is convened and chaired by the AS CU chair. Pursuant to Article 15(2) of the CU Statute, members of the CU academic community and members of the BT CU have **the right to nominate** candidates for the position of rector.

The nomination for a candidate for rector shall include: the name, surname, title, and academic degree of the candidate for rector, their age, a structured professional CV, a proposal for the development strategy of CU, written consent to the candidacy for rector, and an extract from the Criminal Register not older than 3 months. Candidates for the position of CU rector from among the clergy are required to submit the written consent of their own ordinary to their candidacy for the office of rector. A member of the AS CU and a member of the BT CU may not run for the position of rector during their term of office as a member of the AS CU or BT CU.

Nominations for candidates for the position of Rector shall be submitted in a sealed envelope marked as "**Nomination of a Candidate for Rector**" and addressed to the Chair of the Academic Senate of the Catholic University in Ružomberok. Nominations may be delivered in person to the Registry, Records Management and Archives Department of the Catholic University in Ružomberok (Rectorate Mailroom of the Catholic University, Hrabovská cesta 1A, Ružomberok, 1st floor, office no. 0.01) or sent by mail to the address: Academic Senate of the Catholic University, Hrabovská cesta 1A, 034 01 Ružomberok, within the period beginning on the day following the announcement of the election of the Rector of the Catholic University and ending **no later than 7 September 2026.**
